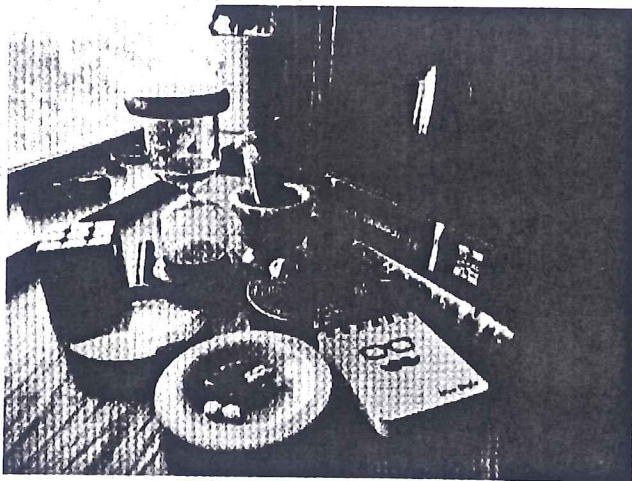

I have been working in prisons and state hospitals in Michigan and California from 1972 until January 18, 2018. The primary task is controlling violence with antipsychotic and other psychotropic medications.

I have been gassed, spat upon, beaten to the floor and blooded at Riverside Psychiatric Hospital in Ionia, MI, Brooks Prison in Muskegon, MI, and Atascadero State Hospital in Atascadero, CA.

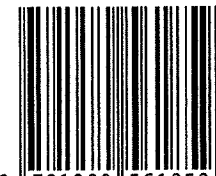
This book is written as a diary by a person who participated in events as they unfolded.

(FORCED MEDICATION HEARING)

DIRECT EXAMINATION

BY MR. DeRUYTER:

Q. Just two brief questions. First, Dr. Risley, um, there was a lot of talk in your cross-examination about controlling Mr. Gambord by sending him to unit 9. What did that actually mean, the word "control" in that context?

A. Basically, they want -- um, they didn't want him to continue making phone calls up in Sacramento. There were some phone calls out. He was trying to disrupt calling multiple Senators when Pam Ahlin, who was the former executive director of Coalinga State Hospital, she was being sworn in. And he was making multiple phone calls in that arena. So, basically, they just wanted him to stop making the phone calls. And so what happened then was he was placed on a one-to-one and his phone privileges were taken away. And he was only allowed to make phone calls if there were approved numbers. And, um, we -- the hospital employee would actually have to make the phone call for him.

Q. Okay. And, lastly, just to refresh, you testified that, um, Mr. Gambord is exhibiting seven symptoms currently that classified him under Bipolar I?
