This has not been a good week between us. I'm not happy with what I've been hearing from you. I have been trying to help you with supplemental income for your personal and dietary needs for a long time and at least a couple of times a year supplementing that with special requests. Just a month or so ago, I responded positively to your request for a potpourri of items amounting to over \$1500.

I have not monitored how you spend the money I've been sending - I really don't want to begin micro managing this. Up until this past week or two, you have lived a rather quiet life getting along as best you can under the circumstances - at least that's what I have known about and believed. Apparently I've missed a lot of what you've been up to.

I HAVE BEEN IN FULL COMPLIANCE - 13+ YEARS - WITH THE TERMS AGREED UPON TO RECEIVE MONTHLY SUPPORT.

With the prospect you may be released, it seems you have become hyper-active - almost manic - in your conversations with me. Your tone has been hysterical. You demand immediate and urgent responses to your questions and requests, very inappropriate behavior. All it does is turn me off to you and head me in the opposite direction from what you want or expect. Several of the voice mails you've left on my phone are hurtful and disrespectful to say the least.

In my recent conversations with you, I became aware of your website "ColingaStateHospital.com". This was a quite a surprise for me to learn from you. This is a fake, fraudulent website - meant to deceive those who would go to this site, as being some kind of official site. You've stepped over the line with this one. Along with this, I have learned your issues with staff at the hospital have escalated into a full-on war of some kind. You've apparently found corruption, incompetence and fraud within the hospital staff and organization and, you've set out to expose it and get it changed. Some might believe it an admirable exercise. I believe it's a total waste of time, energy and resources which, in the long run, is bound to fail.

Corruption, incompetence and fraud can be found in every nook and cranny of every society throughout the world. "So, what else is new", most would ask. If you want to squander your time, energy and resources perusing this kind of issue, you will do so without my support of any kind. It sure isn't an activity that will benefit one Jeffrey Gambord. Quite the opposite - you will be vilified and belittled by all those with any common sense and understanding of the world about us.

I understand you have taken down your fraudulent website. That's good. I know this didn't happen without funding; therefore I'm concerned how you are using the funds I send you. I don't want one nickel of my money going to help you "harass the system".

NOT ONE PENNY WAS USED TO FUND THE \$304,000 ANNUAL COST OF CSHABUSE.COM.

At the end of the month, I will resume a payment to you, beginning with one-half of what I have been sending. From here on, once a month, I want you to send me receipts and copies of statements for how you've spent the funds I've sent you. These funds can be used only for food supplements and personal clothing items that you can substantiate with identifiable receipts and copies of account statements. I will not try and explain in detail how you are to submit these receipts and statements to me; I will leave that to you to send simple, concise verifications of where the money was spent and exactly for what. When I have received backups that are complete and understandable for a past period of time, one month for example, then I will begin to restore the former level of support in a gradual way. It will depend totally on your cooperation.

Penalty/Punishment for what?

For the present time, I don't want to have any telephone conversations with you about this. I think what I've said here is pretty clear. If there is something you don't understand, please send me a note and I will explain it further. You told me you're a very smart guy - I believe that's true - so you should be able to figure out where I'm coming from without much difficulty.

**SUBJECT: FORMAL OBJECTION TO THE NAMING OF THE
"JOEL & DENA GAMBORD BUSINESS AND INFORMATION
AND TECHNOLOGY BUILDING" AT CSUMB AND REQUEST TO
BE HEARD BY THE BOARD OF TRUSTEE'S.**

Dear Chancellor White:

I am the son of Joel and Dena Gambord. I am a registered voter in the State of California and have voted in several statewide measures involving our colleges. I am hereby making a formal objection to the naming of a public facility after my father based in part upon the information I will present in this letter. I am also objecting to CSUMB accepting of any donations from my father on moral grounds. I am asking to speak with the Board of Trustee's by telephone to present more information of an extremely personal and confidential nature.

At the time the Board originally considered and voted to approve the naming of a public facility at CSUMB in honor of Joel and Dena Gambord, I was bound by my father to a financial agreement which rendered me silent as to his character history in exchange for my food and other necessities. I am able to speak now because on June 25, 2017, he terminated that agreement after 13+ years, however, the agreement really originated around 1995.

Speaking strictly as a layman who spent the first two thirds of my life as a criminal hurting people, I assume that we name our public buildings after people in our society whom we hold in high esteem for one reason or another. Certainly on a college campus, I'd assume a building would be named after someone who we want students to admire - someone they

might dream of emulating each time they walked in and glanced up and saw the persons name on the facade.

I don't want to lose credibility here by labeling or name calling, but when I think of some of the things that my father has done to hurt me and my siblings (which he has paid me to stop talking about) I feel that he is a monster and a tyrant.

Lets start with my brother Scot who was never a criminal. He killed himself in December 2008 in Yakima, Washington. He had at least 7 prior suicide attempts. He had been in a nearly fatal car accident with brain trauma and my father taunted him about how he was not going to help him with any "psycho" or "therapy." Enclosed is the email where my father told Scot this and then taunted Scot with the fact that he was going to donate all his money to charity etc.. The students at CSUMB are now going to college on the money Scot needed for therapy and for help. This led to his suicide. My brother was actually half way to Pebble Beach to kill my father at one point and I talked him into turning back Washington. I am also enclosing the email Scot sent my to father instead of killing him. Again, Scot ultimately killed himself by overdose.

I am disabled physically and only able to walk very short distances using a wheelchair most of the time. I have so much pain in my feet and hurts if they barely touch the floor. My father picks on people who are weak and vulnerable.

The evil part about my father is that he is ashamed that his son, "Jeff Gambord" is a sex offender. In 1995, he made me a deal that he would give me money for food and necessities of life in prison on one condition: **STOP DOING TELEVISION INTERVIEWS ABOUT MY CHILDHOOD AND ABOUT BEING A SEX OFFENDER!** I had been featured by major media regarding what my father did to me as a child and how I became a sex offender who could not get treatment in prison. PHIL DONAHUE SHOW, WEST 57th STREET (CBS), SAN JOSE MERCURY CHANNEL 8 (SALINAS), BAKERSFIELD CALIFORNIAN, NEWSWEEK, and many more.

In the early 1980's, I was being raped in prison and sexually assaulted over 14 times. My father refused to send me any money to help me pay for food or necessities then and eventually I had to stab a patient an attacker nine times in self-defense. After a two week jury trial in Bakersfield, I was found not-guilty based on self-defense.

The Bakersfield Californian wrote a lot of stories about how I was being attacked by homosexuals at the Tehachapi prison. I bring this up to validate several points about my father: 1) He didn't send me money for food and necessities when I was being raped in prison and in the newspaper for all that because it wasn't in his readership area; 2) But he did try to send his son money for food & necessities to keep CSUMB and the media from hearing that what they are hearing now.

Enclosed is a letter from my father dated March 3, 2001 where he stopped payment on a check for \$3,000.00 simply because I ran an ad for a "friend" 8-months before my anticipated release from prison. Included is the ad and a follow-up letter where my father expresses his disgust that he has a son named "Jeff Gambord." This is where my I form my judgement that my father is a monster and a tyrant because running an ad for a friend was not a violation of my agreement with him; nowhere in the ad did I mention that I was a sex offender. I was anticipating returning to society after 17 years and instead of asking me nicely to remove it, he cut off my money for food and necessities, just like he did when I was 5 years old. Just like he is doing now to an almost 60 year old man, Chancellor White!

On April 20, 1986, the San Jose Mercury ran a massive front page Sunday story about my entire life, including what my father did to me as a child, which he has been trying to make go away for years by paying monthly to keep me out of the spotlight. On November 1, 1991, The San Jose Mercury ran another front page story about my struggle for therapy and enclosed is a letter my mother wrote to the court dated September 3, 1980, where she describes my fathers abuse of me as a child. On many occasions when I was around 5 years old, my father put a chain lock on the outside of my bedroom door. He would lock me in my room without food until the next day. He would also whip me viciously like a slave owner would whip a slave. When he caught me playing with matches, he would light them, blow them out and then immediately burn me on my arm with them.

I am enclosing a psychological report describing the severe psychological trauma this monster inflicted upon me. The fear of physical injury I lived with as an 11 year old boy.

My father is currently furious that at Coalinga State Hospital, I have become an advocate for men who are dying, I have uncovered corruption, and I am the source of ALL the material on the web site CSHABUSE.COM. He said I am wasting my time and he doesn't believe

this is a worthy cause even though many police officers and doctors are now my friends.

Chancellor White, four months ago, I informed my father that I am due to go to jury trial to determine if I should remain confined as a Sexually Violent Predator at Coalinga State Hospital. My father responded and told me this:

"If you go to trial, you will be rolling the dice mister. If I read one word of it in the press...that's it! I will cut you off for the rest of your life."

I asked my father how he could possibly give me such an ultimatum when two defense doctors are of the opinion that at almost 60 years old, I no longer meet the criteria to remain confined. I told him he was not being fair and that I was entitled to live my life and try to be free before I die. He replied:

"I don't have to be fair..if you don't like it, you can lump it!"

On June 25, 2017, he cancelled a check for my food and other necessities because I left a voice mail for my brother in law to have my sister call me or my mother regarding my upcoming jury trial to be discharged from Coalinga.

My father has now terminated my money for food and necessities of life for the rest of my life because I have contacted CSUMB in this matter. He has also based this termination on my recent contact with CSUMB to insist on disclosure to the students receiving his funds that I am his son, who has a history as a sex offender. As I have stated in several emails the past 3 weeks to CSUMB, Kyle Rowen, CMUMB Counsel, CSUMB Police Detective Heather Murphy, and others, the students at CSUMB are at risk of being traumatized by my fathers deceptions

I believe they may be traumatized by the fact that their college educations are being paid for with funds which my brother scot was deprived of leading to his suicide, and now I am being deprived of food and necessities of life for trying to warn them of these facts. Did you hear me? My father has cut off my money for food and necessities of life - his son who can barely walk; and you have his name on a public building!

Chancellor White, you may determine that none of this is relevant. That is your prerogative, sir, and I will respect that. But what I say to you here and now: 1) What I have said here is only the tip of the ice berg, so to speak, and I am requesting to talk to the Board of Trustee's privately on matters that are even more disgusting, private, and confidential. 2) As a registered voter in this state, I object to CSUMB taking my father's money and placing his name on a building. For the reasons stated in this letter, and those I wish to present to the board, I am going to fight you publicly on this at this point.

You are also hereby also on notice that your office's treatment of me as a criminal in recent days, and threatening me with criminal charges for contacting CSUMB with the information contained in this letter is, will be dealt with separately, perhaps through litigation. I have conducted myself in a professional and courteous manner in every contact I have had with CSUMB and your office. Your most senior staff and administrators have lied to me repeatedly, refused to take any of my calls, and not one person ever spoke to me on any of these matters.
