

Dear Dad & Rusty

MARCH 21, 2022

I am writing to you and Rusty at this time to beg that you please view recent evidence, which in my humble opinion, validates that a terrible mistake was made in 2017 when judgements and characterizations were made about my actions, my motivations, my goals, including an allegation of fraud and deception. All of this was contained in my dad's 7/17/17 letter, accusing me of taking on corruption, incompetence, and fraud - but that was NEVER the core issue! The core issue was human suffering and DEATH, which I began speaking and reporting on in late 2012 / 2013, over a decade ago!!

LAST Year - JULY 2, 2021, Valley Public Radio, KVPR.ORG, reported that Calinga State Hospital had a death rate which could not be explained by patients age, expected health factors, or covid; its death rate was higher than any state prison (seven times higher), and almost (twice the average) of the entire California State hospital system. Enclosed are reports which I wrote in 2013 and 2016. The 2013 report was the verbatim text for the website which you took offense with. I am also enclosing copies of letters which I sent you in MAY 2016 and JUNE 2016. AS OF your 7/17/17 letter, my name had not appeared publicly in connection with any of these activities, which was intentional (in keeping with the spirit of the family wishes that I do my best to live a low-profile life.) I never hid anything from you, but did caution in my June 2016 letter that someday I might be recognized for doing something "GOOD."

Here we are now in 2022, and there is much for you to see that you unfortunately did not see in 2017. Quite frankly, there is ALOT for you to be amazed and proud of, if not shocked!! What could that be you ask?

Around 2009, I started developing
a deep empathy for others after watching
~~4000~~ documentaries about all aspects of
LIFE. I began wanting to help others
and wanting to make a change where I
saw hurt and pain in the world. I
was also inspired by Michael Pollock's
charity, the work you were doing with
the K-9 College, and a letter you sent
me Sept. 30, 2000, made me feel
I could do something good with my
life in "my community" (here) which was hurting.

Your July 17, 2017, letter hurt
me to the core, mostly because you
didn't see that you actually had a son,
or the son. Any father would want.
All you were thinking was that "here

is my son doing things to bring more shame/publicity to our family."

I have spent the past 10 years fighting for people dying because they were not getting proper medical care. It was never about staff stealing paper clips or stolen office furniture, but over 200+ dead patients, fraudulent in-house death investigations, forged Annual Physical Exams, years of denied medicatory Annual/Duty Physical exams doctors who barely spoke English, paper medical records that are purged every few weeks — then filed away to dead storage.

A couple years ago we launched a YouTube channel (DSHABUSE) where you can hear Dr. Koekes tell me in 2014 that "The issue you brought up of people dying and nobody caring came up in several doctors meetings, then went back underground. If you keep digging deeper, they will try to hurt you."

In my YouTube channel, you can hear Officer Pica telling me to go to the FBI or DOT; have them interview ALL the staff to find out what goes on here. Many staff confided in you so their desire.

I am able to do a lot of this with help from a modest sponsor in EGYPT and a couple of kids he has had work for me handling my email & internet, from EGYPT via VPN!

In 2018 I moderated a conference call with 3 State Assembly offices and several other dignitaries, posted on CSHABUSE.COM, and 19st ^{year} we launched DSHABUSE.ORG

I also conducted investigations at Patton State Hospital and Atascadero State Hospital, uncovering human abuse going on there. My interviews with those patients are posted on the DSHABUSE/Youtube channel.

I turn 62 this year. I've been diagnosed with ~~a~~ cirrhosis of the liver (from "FATTY" liver; NOT from drinking).

I am at an impasse with my advocating as the world is in chaos, covid, etc., and nobody cares what is going on with the State Hospitals. We have 350 regular Mental Patients here; nobody cares about them either. I can't even get Disability Rights California to push for a State Audit on the validated extraordinary death rate at this facility (the enclosed docs speak to this topic).

In closing, I felt that your position toward me on July 17, 2017, was an unprovoked and undeserved mistake based on the totality of the circumstances and evidence I have presented you in this letter.
